I am director and co-founder of the non-partisan, non-profit citizens' organization [Center for Judicial Accountability, Inc.](#) (CJA)

Your Chief Counsel Cydney Kelly and your Investigator Carolyn Stachura have corrupted their offices – and are the subject of complaints to you that I have embodied in two requests for full Committee reconsideration of their fraudulent [February 28, 2024](#) and [March 27, 2024](#) letters informing me of the dismissals of two separate, yet related, fully-documented complaints against Attorney Louis Dingeldey and Attorney Eugene Fahey, each of a far-reaching and serious nature, involving public corruption. According to the letters, there was “insufficient evidence” and “no evidence”, following implied investigation.

The reconsideration requests, dated and mailed March 29, 2024 and April 10, 2024 to your Buffalo office, are above-attached. CJA's webpages on which the reconsideration requests are posted, with the complaints and the other correspondence relating thereto, are, respectively, [here](#) and [here](#).

Please note that the [October 25, 2023 complaint](#), arising from a sealed Monroe County Family Court case and the [Independent Expert Report](#) on which it rests, which I mailed to Chief Counsel Kelly with my [January 29, 2024 complaint form for Attorney Dingeldey](#) and [January 29, 2024 complaint form for Attorney Fahey](#), have, **as posted**, been redacted to remove the names of the innocent parents.

Kindly forward this e-mail to those members of the Committee whose e-mail addresses I could not immediately find – and, additionally, to AD4-AGC8, whose e-mail address you assuredly have.

I am available to answer questions and would welcome the opportunity to do so, under oath, to you – and to Unified Court System Inspector General Porter Campbell, cc'd on the April 10, 2024 reconsideration request.
