I have received no response to my below July 7<sup>th</sup> e-mail to you regarding my [February 11<sup>th</sup> complaint against Attorney General Letitia James and Solicitor General Barbara Underwood](#). Haven't you – by now – sent the complaint to them for their responses? And why have you not sent those responses to me for reply? Isn't that the normal and customary procedure when you "investigate" a complaint?

Please advise without further delay, furnishing me, as well, with the two docket numbers you have assigned for the complaint against each of them.

Please also advise why, on September 29<sup>th</sup>, your Administrative Assistant, Celina M. Nelson, sent me three e-mails, apprising me that because three attorneys, [Frederick Brodie, Esq. \("Docket No. 2021.0846"\)](#), [Christopher Liberati-Conant, Esq. \("Docket No. 2021.0845"\)](#), and [Helena Lynch, Esq.](#)

[\("Docket No. 2021.0847"\)](#) are not within your geographic jurisdiction, you, therefore, would be taking "no further action" on my "complaint" against them, when:

- (1) the unidentified "complaint" – that of February 11<sup>th</sup> – had not been filed with you against these three attorneys for that very reason;
- (2) there was no basis for your assigning to these three attorneys docket numbers for a February 11<sup>th</sup> complaint I had never filed with you against them; and
- (3) there was no need for you to inform me that you did not have jurisdiction over them because – as clear from my February 11<sup>th</sup> complaint (fn. 1) and your complaint form, which I had completed -- I knew that already.

As Ms. Nelson's three September 29<sup>th</sup> e-mails may have been prompted by my [September 28<sup>th</sup> e-mail to Unified Court System Inspector General Sherrill Spatz](#) entitled "UPDATE & RECORDS REQUEST -- CJA's unresponded-to Aug. 27, 2021 complaints vs 1st & 3rd Dept. Appellate Division Attorney Grievance Committee Chief Attorneys Dopico & Duffy" -- to which Unified Court System Assistant Deputy Counsel/Records Access Officer Shawn Kerby was cc'd – I am cc'ing both of them on this e-mail to further reinforce Inspector General Spatz' duty to investigate what the 1<sup>st</sup> Dept. Attorney Grievance Committee has been doing, over the past nearly nine months, with my open-and-shut, FULLY-DOCUMENTED February 11<sup>th</sup> complaint against Attorney General James and Solicitor General Underwood and as a reminder that I have received no response from either of them to the September 28<sup>th</sup> e-mail, whose three attachments are [here](#), [here](#), and [here](#).

Other than an April 9<sup>th</sup> automated acknowledgment of receipt, I have received no response to my below April 9<sup>th</sup> e-mail inquiring about CJA's February 11, 2021 conflict-of-interest/misconduct complaint against Solicitor General Barbara Underwood, filed with you – and against Attorney General Letitia James, filed with the Second Department Attorney Grievance for the Second, Eleventh, and Thirteenth Judicial Districts, which its chief counsel stated to be within your jurisdiction as well.

What numbers have you assigned to the complaint against Solicitor General Underwood? And how about the complaint against Attorney General James?

As a supplement to the February 11, 2021 complaint against both of them pertaining to their litigation fraud in *Delgado v. **TO: First Department Attorney Grievance Committee**

I have received no acknowledgment from you concerning my February 11, 2021 attorney misconduct complaint against New York Solicitor General Barbara Underwood that I e-mailed you by the below – and then, on February 12, 2021, sent you by priority mail (#9505514189661043469592), together with its sole enclosure: my February 7, 2021 judicial misconduct complaint, filed with the Commission on Judicial Conduct.

According to the above-attached USPS tracking receipt, it was delivered on February 16, 2021.

By contrast, in response to the same February 11, 2021 complaint, filed with the Second Department Attorney Grievance Committee for the Second, Eleventh, and Thirteenth Judicial Districts against New York Attorney General Letitia James, its Chief Counsel Diana Maxfield Kearsse sent me a March 3, 2021 letter stating that although Attorney General James is admitted in the Second Department, she “is currently registered at a business address in Manhattan”, and, therefore, “the appropriate Grievance Committee is the one in the First Department”.

In the event Chief Counsel Kearsse did not “blind copy” you on her March 3, 2021 letter to me, it is above-attached – as is the complaint form I filed with the Second Department Grievance Committee for my complaint against Attorney General James.

Suffice to further note that in response to the February 11, 2021 complaint, filed with the Third Department Attorney Grievance Committee against four subordinate attorneys in the Attorney General’s office, its Chief Attorney Monica Duffy sent me a March 9, 2021 letter requesting separate complaint forms for each attorney, with specifics as to the misconduct of each.

As the specifics as to those subordinates further substantiate the February 11, 2021 complaint against Attorney General James and Solicitor General Underwood for their wilful violation of their supervisory/managerial responsibilities (Rule 5.1 of the New York’s

Code of Professional Conduct), above-attached are my four separate complaint forms against those attorneys, each dated April 3, 2021.
