Thank you for your 2:45 pm return call, supplying me with your e-mail address.

As briefly discussed, I am e-mailing you <u>directly</u> because it is now more than five months since I e-mailed AGC-3 my above-attached and here-linked <u>September 20, 2021 letter</u> requesting reconsideration of <u>Chief Attorney Duffy's August 25, 2021 "Notice of Declination to Investigate a Complaint"</u> -- and have received NO response. As required by <u>22 NYCRR §1240.7(e)(3)</u>, my written request was addressed to you and, pursuant thereto, requested that you refer the request "to the full Committee".

On <u>February 17, 2022</u>, I e-mailed AGC-3 to verify that the reason I had received NO response was because NONE had been sent – and to inquire whether Chief Attorney Duffy had even furnished my September 20, 2021 letter to you – and whether you, in turn, had furnished it "to the full Committee". I received NO response and, on <u>February 22, 2022</u>, e-mailed AGC-3 again. STILL received NO response.

Below are all the referred-to e-mails I sent.

Please advise whether you and "the full Committee" know anything about my September 20, 2021 letter.

Additionally, please respond to my two included FOIL requests which AGC-3 has also ignored – the first at footnote 4 of my September 20, 2021 letter and the second particularized by my February 17, 2022 e-mail.

I also herein make a third FOIL request for:

- (1) records pertaining to the <u>specific</u> responsibilities of an AGC-3 chair for the proper functioning of the Committee, beyond what is set forth in <u>\$806</u> and <u>\$1240</u>, including with respect to initiating a misconduct complaint against the chief attorney and applying to the Appellate Division, Third Department for the chief attorney's removal for cause;
- (2) records reflecting the name of the Committee's <u>current</u> "vice-chairperson", required, like yourself, to have been appointed, pursuant to §806.4(a), by the Appellate Division, Third Department "from among the Committee membership after considering the recommendations of the Committee" inasmuch as the <u>posted roster of "Committee Members" for 2021-2022</u> does NOT indicate a vice-chair; and
- (3) records reflecting the Appellate Division, Third Department's compliance with §806.4(a) by its <u>annual</u> appointments of the Committee's chair and vice-chair, from 2012 to the present.

As I mentioned, I had not intended to send this e-mail to AGC-3's other members *before* giving you a chance to respond. However, because in the hours since my 9:20 am voice message for you and my 10:05 am written message for you, *via* your law firm's "contact" webpage I had begun to despair that you would be supplying me with your e-mail address that I was requesting, I had – from about 2 pm – telephoned six AGC-3 members for their e-mail addresses, explaining, mostly in voice messages, that because I had been unable to obtain from you your e-mail address I was reaching out to them. In any event, I trust you will agree that <u>each</u> AGC-3 member bears responsibility for the Committee's proper functioning, not just you, as chair.

Not all AGC-3 members are here cc'd because I could not find their e-mail addresses on the internet and was unable to obtain them. I respectfully request that you yourself forward this e-mail "to the full Committee" for determination with my September 20, 2021 reconsideration request and initiate discussion of the <a href="https://doi.org/10.2021/journal.org/">https://doi.org/10.2021/journal.org/</a> disqualification, for financial and other interests, and bias arising from relationships, of specific AGC-3 members. I trust you will ask each member to make appropriate disclosure.
