Who are the scholars of New York's state Constitution, governance, and politics on whom you will be relying for expert comment on these? Below is my November 29th e-mail to key scholars to ascertain who they might be.

Suffice to say, such scholars as you solicit for expert comment should be queried as to their knowledge of my document-substantiated September 17<sup>th</sup> oral and written testimony to the Commission to Investigate Public Corruption and subsequent correspondence, as for instance, my October 17<sup>th</sup> letter to the Commission. Here's the link from the Center for Judicial Accountability's website: <http://www.judgewatch.org/web-pages/searching-nys/commission-to-investigate-public-corruption/people-evidence/sassower-elena.htm>, from which you can access these, together with my July 19<sup>th</sup> documented corruption complaint to Albany County District Attorney Soares – a Commission member – encompassing my documented criminal and ethics complaints to, *inter alia*, US Attorneys Bharara, Lynch, and Hartunian, the Joint Commission on Public Ethics, and the Inspector General pertaining to the corruption of the state's budget process involving the unitemized, slush-fund Judiciary and Legislative budgets, as to which there is NO oversight by the Executive branch, *to wit*, the Division of Budget, Governor, and Comptroller.

Suffice also to say, in addition to querying the scholars about the sufficiency and seriousness of this primary-source documentary evidence, you might ask them whether they would not agree that my direct, first-hand experience, as reflected therein, qualifies me to furnish you with informed comment about the Commission and budget process.

I look forward to the opportunity of providing you with such comment – and answering all your questions.

**Subject: BUILDING SCHOLARSHIP: Commission to Investigate Public Corruption -- & the Upcoming Budget for Fiscal Year 2014-2015**

Dear Professors, Etc.

This Sunday, December 1, 2013, is the date by which – pursuant to Section VIII of Governor Cuomo's Executive Order #106 -- the Commission to Investigate Public Corruption is required to issue a "preliminary policy report...setting forth its initial findings and making such recommendations...for the express purpose of consideration and enactment of statutory reforms by the Governor and the Legislature in the 2014 legislative session".



It is also the date by which – pursuant to Article VII, Sec. 1 of the New York State Constitution -- the Judicial and Legislative branches are required to furnish their “itemized estimates” of their “financial needs” to the Governor, with a copy of the Judiciary’s “itemized estimates” “transmitted to the appropriate committees of the legislature”.

If your scholarship does not embrace these, I trust you will not be writing or giving comment to the press about them. If, however, they are within your scholarship, please let me hear from you *as soon as possible* about the primary-source documentary evidence of which my below October 24<sup>th</sup> e-mail gave you notice. To date, I have received no response from even a single scholar to my [August 21<sup>st</sup> letter to the Governor](#) or to my [August 5<sup>th</sup> letter to the Commission](#), let alone to my [September 17<sup>th</sup> written and oral testimony to the Commission](#) or subsequent correspondence as, for instance, my October 17<sup>th</sup> letter to the Commission, posted as our webpage entitled: [The People Have Something to Say -- & Evidence to Back It Up](#).

How would you explain this? Is there an explanation other than conflicts of interest?

Needless to say, New York government will never be other than flagrantly and systemically dysfunctional and corrupt unless we build honest scholarship that is methodologically-sound and based on primary-source documentary evidence that is not cherry-picked. To that end – and especially if you will not be confronting this evidence – I would appreciate the names of other scholars of New York’s Constitution, governance, and politics to whom we and the press can turn.

“Wow! What a devastating presentation. Thank you Joel Rose for writing this -- and Artvoice for circulating it. I will e-mail it to reporters & editors, political and constitutional scholars & commentators -- and to the membership of our non-partisan, non-profit citizens' organization, Center for Judicial Accountability, Inc. (CJA), with a request that it be forwarded on, and on, and on.

I would note that on October 8th, [Bill] Samuels, who funds an organization called "Effective New York" and another called "New Roosevelt", held a conference on a new New York Constitution, with the first segment on the six constitutional propositions on this year's ballot, including one to raise the mandatory retirement age for various NYS judges from 70 to 80. In the question portion, I asked how many of these constitutional propositions were the product of a legitimate legislative process -- that is, introduced by legislators into committee, with public hearings then held at which citizens and experts could testify, followed by debate by committee members based thereon, mark-ups, amendments, committee votes -- embodied in committee reports -- then moved to the full Senate and Assembly, with debate and amendments before votes -- with the final legislation of each house then reconciled by conference committees. Only by such process are we protected against flawed legislation. The answer from the panelists was -- or so it seemed -- that none of the constitutional propositions on the ballot had resulted from such process.

We, the People, must take action to protect the desecration of legitimate, constitutional governance by our public officers -- and by their protectors in the media, academia, and elsewhere.
