I am rushing out the door right now. ALL the legislators are up for re-election – and a great many, such as Assemblyman Steck, are lawyers. They certainly know how to evaluate the significance of lawsuit challenges – as, for instance, CJA lawsuits challenging the constitutionality and lawfulness of the statutes establishing the Commission on Judicial Compensation and the Commission on Legislative, Judicial and Executive Compensation, as written and as applied. Their duty was to reveal to you that, AS A MATTER OF LAW, any fair and impartial tribunal would have to strike down the statutes and the Commission reports – with a "claw-back" of the \$200 million dollars already disbursed in judicial and district attorney salary increases and related salary-based non-salary benefits.
