How many of this state's 62 district attorneys are up for re-election this year? And how many of those district attorney races are uncontested –notwithstanding the district attorneys are essentially the highest paid, county-elected officers whose salaries come out of the county budgets.

Here's the webpage of what you need to know about Albany County D.A. Soares, who is running for re-election unopposed – either actually or essentially – and about the state's other district attorneys, colluding with him in violating "The Public Trust Act" and other penal provisions they are duty-bound to enforce with respect to their district attorney salaries – and the judicial salaries on which their district attorney salaries are based.
