The lawsuit is a citizen-taxpayer action – and I testified about it at the Senate and Assembly budget hearings on January 30th & January 31st. Not only is it EXCLUSIVELY focused on the <u>legislative budget</u>, but it presented 26 "Questions that Legislators & Appropriate Committees Should be Asking Temporary Senate President John Flanagan and Assembly Speaker Carl Heastie about their Proposed Legislative Budget for Fiscal Year 2017-2018 & Legislative/Judiciary Budget Bill #S.2001/A.3001" – not a single one of which was ever publicly asked or answered.

These 26 questions are ready-made for you to ask – and will enable you to rapidly expose the far larger scandal of the UNCERTIFIED & CONTRIVED, SLUSH-FUND LEGISLATIVE BUDGET – whose dollar amount, including reappropriations, is completely UNKNOWN.
