**Subject: Elections 2020: Your opinion piece in today's Gotham Gazette. Are you unaware that inclusion of non-fiscal policy legislation in the NYS budget is UNCONSTITUTIONAL?**

**TO: Assemblyman Robert Carroll, Esq.**

This follows up the voice mail message I left for you, shortly before 11 am today, at your Albany office (518-455-5377), which switched to your district office, pertaining to your today's opinion piece in the Gotham Gazette, "State Budget Negotiations are Focused on the Wrong Priorities; We Need an Emergency Coronavirus Package".

You seem to be unaware that inclusion of non-fiscal policy legislation in the New York State budget is UNCONSTITUTIONAL – and that the particulars of this were laid out, 12 days ago, in the Center for Judicial Accountability's above-attached March 18, 2020 letter to Governor Cuomo, simultaneously sent to the Legislature's 15 Leaders who continue to receive stipends for the "significantly more work" and "additional duties" they are expected to perform.

Below is the March 23<sup>rd</sup> e-mail I sent to the Gotham Gazette requesting its investigation and reporting of the March 18th letter, to which I received no response.

As you are a lawyer, in addition to being a legislator, the Gotham Gazette would clearly benefit from your response to the March 18<sup>th</sup> letter – including as part of its 2020 election coverage. I assume you are running for re-election.

Is it your view that the March 18<sup>th</sup> letter is of no significance and can properly be ignored by Governor Cuomo and Legislative Leaders? What will you do to secure from them their findings of fact and conclusions of law? And since it appears that Legislative Leaders have not forwarded the March 18<sup>th</sup> letter to rank-and-file legislators, like yourself, will you forward it to them so that they – and the Governor – may be held accountable for the flagrant violations of the New York State Constitution that are and have been taking place.

Please advise.

I take this opportunity to remind you that we previously met, on September 10, 2019, when – following your terrific testimony before the Public Campaign Financing and Election Commission, raising constitutional objections – I spoke with you briefly, furnishing you a copy of my above-attached letter to the editor "*A Call for Scholarship, Civic Engagement & Amicus Curiae Before the NYCOA*", as published in the August 21, 2019 New York Law Journal. As you were not present when I testified – and my testimony was misrepresented by the Commission's December 1, 2019 report (at p. 97) – here's CJA's webpage for it: <http://www.judgewatch.org/web-pages/searching-nys/force-of-law-commissions/part-xxx-2019budget/9-10-19-hearing.htm>. As you can see, I supported my testimony with the SAME August 21, 2013 letter to Governor Cuomo on a "...Properly Functioning Legislature" as is the SOLE enclosure to the March 18, 2020 letter to him.

A propos of your March 16, 2020 press release "*Good Gov't Groups to NYS Lawmakers: 'Keep Policy Out of the Budget'*" – reported by the Legislative Gazette on March 18, 2020 in a story entitled "*Watchdog groups, Republican lawmakers make plea for a transparent and policy-free budget this year*" – this is to reiterate what I have previously alerted you to: that the inclusion of policy and non-budgetary items in the state budget is UNCONSTITUTIONAL.

The details are set forth in the Center for Judicial Accountability's above-attached March 18, 2020 letter to Governor Cuomo, sent to him and Legislative Leaders by the below e-mails. Entitled "GOOD NEWS DURING THE CORONAVIRUS EMERGENCY: You Can Chuck 6 of the 7 'Article VII Bills' Because They are Unconstitutional. Here's why...", it analyzes the Governor's "Article VII Bills" for FY2020-21 and does so in the context of the Court of Appeals' seminal 2004 decision in *Pataki v. Assembly/Silver v. Pataki*, 4 NY3d 75, providing what appears to be the FIRST scholarship deconstructing its plurality, concurring, and dissenting opinions.
