**TO: Rochester Mayor Lovely Warren –**

Following up our brief conversation shortly before 3 p.m. today, below is my self-explanatory chain of e-mails to Rochester Beacon Publisher Zapesochny, culminating in my e-mail to him at 12:37 p.m., pertaining to the above-attached EVIDENCE that he does NOT deny would enable you to support a successful defense that you are being selectively and invidiously targeted by a political-motivated prosecutor – indeed, by a prosecutor whose OWN crimes are more serious – by far – than anything alleged against you.

By the way, the links to the VIDEOS of the January 30, 2017 and February 5, 2018 legislative budget hearings on “local government officials/general government”, at which you testified – as did I, last – are [here](#) and [here](#) – and such are part of the mountain of open-and-shut, *prima facie* EVIDENCE substantiating the FULLY-DOCUMENTED June 18, 2020 public corruption/grand jury complaint against Monroe County’s incumbent state legislators that Monroe D.A. Doorley is “sitting on”. CJA’s webpage for Monroe County, on which you can access my 2016 correspondence to D.A. Doorley and Monroe County – and the conflict-of-interest complaint that I filed against her – is [here](#).

I invite you to call me again, with any questions – and also your lawyer, Joseph Damelio, as likewise Michael Schiano, the lawyer representing Rochester Finance Director Rosalind Brooks-Harris, whose legal assistant, Sally, I spoke with shortly before you returned my call.

I have no contact information for John DeMarco, the lawyer representing Albert Jones, and ask your assistance – and that of Messrs. Damelio and Schiano – in getting this e-mail to him. As will be immediately obvious to Mr. DeMarco, having been a judge for a decade until just this past January 1, 2020, he has a HUGE financial interest in the June 18, 2020 public corruption/grand jury complaint. I presume he will disclose same to Mr. Jones and, by reason thereof, disqualify himself from furnishing his client with a legal opinion as to its usefulness for purposes of a defense.

By copy of this e-mail to Publisher Zapesochny, I call upon him to belatedly render his expert opinion with respect to the above EVIDENCE that he has had since November 16<sup>th</sup> – and to revise/retract the expert opinion he gave by his November 12<sup>th</sup> article "[The risks facing Warren and Doorley](#)" consistent therewith.

It does not appear that I e-mailed you [the indicated letter](#) – most likely because I had not seen your response – at least not before Underwood's May 22, 2018 election, by the Legislature, to be interim Attorney General. **TO: ROCHESTER BEACON**

Unbeknownst to me – when I left a voice mail message on Friday afternoon and sent the below November 13<sup>th</sup> e-mail offering you a LEAD – is that Publisher Zapesochny had written a November 12<sup>th</sup> article "[The risks facing Warren and Doorley](#)", which, if not then, is now prominently posted on the homepage of your website.

Publisher Zapesochny's article – **which is predicated on the integrity of D.A. Doorley, NOT on EVIDENCE made publicly available** -- would doubtless have been markedly different had he known what D.A. Doorley did NOT reveal at [her October 2<sup>nd</sup> press conference](#) wherein she announced: "We are here today to be transparent and up-front with the People of Monroe County" – namely, that she was "sitting on" the above-attached June 18, 2020 public corruption/grand jury complaint against Monroe County's state legislators for penal law violations including [§190.65 "Scheme to defraud in the first degree"](#) – where the EVIDENCE against them is open-and-shut and *prima facie* – a claim she did not make with respect to the indictments she was announcing against Rochester Mayor Warren and her two colleagues for violating Penal Law §190.65, expressly disavowing any "comment on evidence".

Please forward this e-mail to Publisher Zapesochny, with my request that he call me. Would he not agree, based on the June 18, 2020 complaint, that D.A. Doorley must herself be indicted for Penal Law §190.65 and other violations – and on EVIDENCE that is open-and-shut and *prima facie* as to her. Indeed, although D.A. Doorley concluded her October 2<sup>nd</sup> press conference by asserting, "This is not political. I am the chief law enforcement officer for Monroe County. I was presented with an investigation. I reviewed the facts. I presented this case to, well, my team presented it to a grand jury, as we would any other case, and the result is the indictment we are handing down today. It is not political—I am simply doing my job", wouldn't lawyers for Mayor Warren and her colleagues have an easy time proving – based on the June 18, 2020 complaint -- bad-faith, invidious, selective-prosecution by a self-dealing, politically-motivated prosecutor – and that D.A. Doorley's crimes are all the more egregious as she is [president of the District Attorneys Association of the State of New York](#), presumably knowledgeable of, if not orchestrating, comparable Penal Law §190.65 and other violations by New York's [61 other district attorneys](#), each withholding materially-identical complaints from grand juries

I take this opportunity to note that much of the EVIDENCE substantiating the June 18, 2020 complaint is embodied by a May 18, 2018 letter I sought to furnish Mr. Zapesochny 2-1/2 years ago in connection with his candidacy for appointment as interim New York state attorney general. My May 18, 2018 e-mail to other A.G. candidates identified my outreach to him – and it is accessible, with that EVIDENCE,

As I am intending to contact the lawyers for Mayor Warren and her fellow defendants, I look forward to hearing from Publisher Zapesochny SOON. This would include with respect to the LEAD, to which – disappointingly – I have received NO response.
