For your convenience, here, in a single e-mail, are:

- (1) my [July 11th e-mail](#) , my [July 13th e-mail](#), and my [July 14th e-mail](#), alerting you, with EVIDENCE, to Zohran Mamdani's corruption as a NYS assemblyman, being covered-up by The New York Times, and so-demonstrated through its controversial article that was the subject of your July 7th column "[Mamdani and the consequences of woke racial classifications](#)", **without response from you;**
- (2) my [July 20th e-mail](#) entitled "ALERT: Mamdani can easily be defeated. All it requires is an honest press, reporting on his corruption as a NYS assemblyman, for which he must be indicted & will be convicted. Can you help?", occasioned by your publication, on that very day, of Dan Diker's "[Lessons in populist propaganda and totalitarian takeover](#)", **without response from you;** and
- (3) my [August 17th e-mail](#) entitled "URGENT: Honest Reporting Required About Mamdani & the NYC mayoral race that NY's largely anti-Israel press is concealing, in toto, to rig his election & dispirit & deter Jewish, pro-Israel opposition", referencing your August 13th publication of Irit Tratt's "[Mainstream Jewish groups shy away from scrutinizing Mamdani](#)", **without response from you.**

Now, further summarizing the situation – apart from [the shonda of the abandonment and betrayal of Jews and Israel by their own press, organizations, and leaders](#) – is my above-attached and [here-linked](#) announcement "MOBILIZING NEW YORK'S JEWISH, PRO-ISRAEL, AND OTHER COMMUNITIES -- SPREAD THE WORD – Mamdani's Win as NYC Mayor is being Rigged by the NYT & Other NY Press, Concealing his Corruption as a NYS Assemblyman – A Scandal He Cannot Survive".

If it is not your intent to do your duty and report on THE SCANDAL MAMDANI CANNOT SURVIVE, to which I have now alerted you by six e-mails, notwithstanding the great amount of journalism JNS has devoted to the threat Mamdani poses to Jews, Israel, and the United States, *inter alia*, by your July 1st column "[Mamdani apologists play the fake Islamophobia card](#)", pivotally highlighting the NYT, your July 3rd "Think Twice" podcast "[Mamdani's win is a warning sign of peril for American Jews](#)", and your August 18th column "[On Israel, Mamdani is no longer a Democratic outlier](#)", stating that "the chances of defeating him are slim" – when they are 100%, based on EVIDENCE you've had for seven weeks – and **notwithstanding** your yesterday's publication of Leonard Grunstein's "[Avert a hostile takeover of the Democratic Party](#)" and, on July 3rd, your publication of Eric Levine's "[Zohran Mamdani hates Israel and](#)
