MESSAGE:

This fax follows our third lengthy telephone message for Mr. Turbin, apprising him of my complaint concerning criminally fraudulent and collusive conduct on the part of Assistant Attorney-General Jay Weinstein before the lower district court. This serious situation calls for immediate supervisory attention by his superiors at the Attorney-General's Office, as detailed in my January 14, 1997 urgent letter to Attorney-General Vacco -- to which I have received no response whatever. A copy of January 14, 1997 letter is enclosed for your convenience. It is simply shocking that when we called a short while ago, we were again told that Mr. Weinstein is handling the appeal.

It is *not* my intention to be subjected to a repeat of Mr. Weinstein's utterly dishonest and sanctionable conduct on appeal. Indeed, when we spoke with him on Friday, he refused to identify whether he had read the appellate brief and flatly refused to discuss a stipulation for appropriate injunctive and stay relief, thereby requiring me to be burdened with a needless motion for relief to which I am entitled, *as a matter of law.*
