Enclosed is CJA's August 3, 2000 judicial misconduct complaint against Chief Judge Judith Kaye, to which you are each indicated recipients.

Such *facially-meritorious* complaint, filed with the New York State Commission on Judicial Conduct, is based on Chief Judge Kaye's *non-response* to CJA's April 18, 2000 letter to her. As you know, including from CJA's June 30, 2000 letter to Chief Judge Kaye, to which you were each indicated recipients, CJA's April 18th letter constitutes a formal misconduct complaint against Mr. Colodner. It also requests clarification of the Chief Judge's supervisory power and her administrative and disciplinary responsibilities, pursuant to §§100.3C and D of the Chief Administrator's Rules Governing Judicial Conduct.
